METHOD OF PAYMENT: Deposit of 1/2 the total due immediately AND balance of \$

Thank you for choosing A Rhymin Rhythm Film for your video needs. The purpose of this contract is to prevent any misunderstanding concerning the obligations of a security deposit. Deposits are non-refundable and serve to lock the date for your event, so that A Rhymin Rhythm Film does not book any work that would conflict with our involvement in your event. If you choose to cancel, before the time frame mentioned in this contract only half of the deposit is refundable. Excluding Special Deals. Once payment is made following any special, there are no refunds. Time is subject to up to 6 months to honor set special. The underlying purpose of A Rhymin Rhythm Film requiring a deposit is to ensure that A Rhymin Rhythm Film does not over-extend its renting/service capabilities. This includes the equipment, personnel and time necessary to ensure a high-quality experience. This is also a guarantee to the customer that they will

receive the requested equipment/personnel on the date specified. In exchange for this commitment of equipment/service for the specified event, A Rhymin Rhythm Film requires a security deposit as good faith consideration. In the event that the event does not occur due to cancellation, low ticket sales, or any other reasons, the coordinator will forfeit the deposit.

TERMS OF AGREEMENT

1. Videographer will provide own production equipment (camera, tapes, etc.) unless otherwise indicated. Lights can be provided with the equipment I have. However, any extra lights or special gear would be the client's responsibility.
2. Videographer will maintain proper decorum in regard to volume, language, dress, etc. at all times.
3. This is a basic, direct agreement between Videographer and employer and does not involve management agencies, etc.
4. Videographer must be informed as to any potential problems including inclement weather, alternative locations, electrical power availability, civil disturbance, etc. Videographer makes every effort to fulfill commitment, but cannot perform outside causes beyond videographer's control.
5. Videographer reserves the right to cancel or reschedule engagement in the event of catastrophic accident, illness, transportation problems, or other unforeseen difficulties, which could arise as an "Act of God."
6. Videographer will make every effort to ensure a smooth, timely, and enjoyable engagement.
7. If you choose to cancel you may do so within a week or 7 days before the event. However, only half the deposit is refundable, and A Rhymin Rhythm Film has 7 days to return half the deposit. The deposit is NOT refundable if canceled within a week. The remaining balance is due the day of the shoot before we start shooting.
8. The payment is for an edited video as discussed, after the project is completed, I DO NOT keep any of the raw footage. I only keep the master file. Everything else get's deleted for new space for projects. If you would like to purchase all the raw footage for yourself, there is a \$50-\$75 fee depending on how much footage we shot. This will release any copyrights on my captured work on extra or all of the footage taken at the event that may or may not be in the final render, to use freely without permission. Please let me know before I delete.
9. Also, my Signature tag "A Rhymin Rhythm Film" will be place during the first minute of the film on every project I create unless paid for this to be removed. Fee to remove is equal to the amount of the video (Subject to change). If special platforms require this to be removed, Directed by "Matthew Hyder" will be replaced in the video for credit. Otherwise this signature will be placed as indicted.
10. Once the project is finished and client agrees and likes the final render, A Rhymin Rhythm Film may use the video after client has published it live on his site to show case my work for other clients. A Rhymin Rhythm Film may not publish before the client does.

11. Client may have two (2) revisions on the master file if they see something they don't like or want changed. Any revisions here after are \$20 for each revision and may be paid through paypal, cash, or cash app.

12. Videographer may bring 1 to 2 guests, if needed, to help with gear or lighting for event. Client is responsible for the entry fee, if any, for the additional personal. This will be discussed before the event takes place.

13. For any specials or promotions that A Rhymin Rhythm Film may be doing, are strictly bound to those details described in the special. If purchased at the regular rate details can be discussed about special instructions the client is looking for.

14. Each additional location the client wishes to film at is \$50 for each. This is NOT included in the rate. This is explained on the site and will also be discussed before hand during the details of the project.

15. Client will have up to 5 hours of shooting time. Additional hours that exceeds the 5 hours mark is an additional \$30/hr
